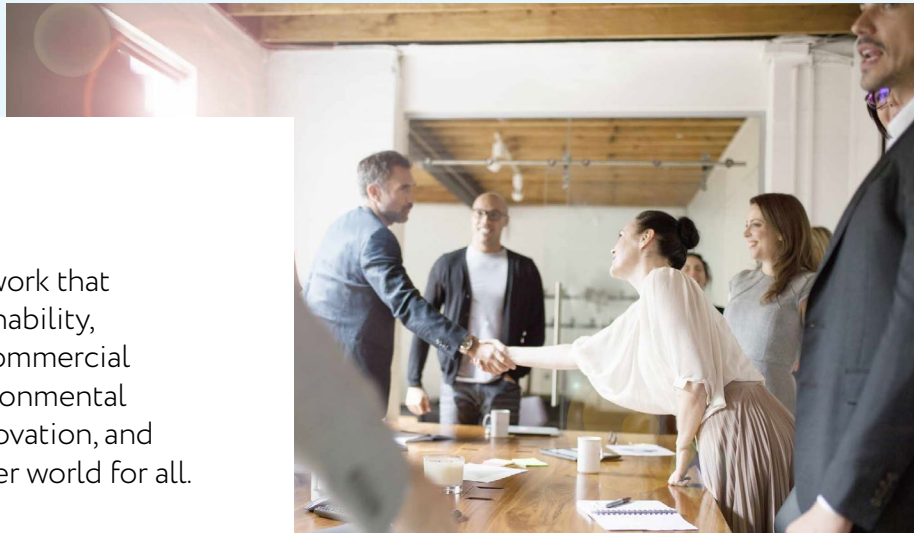

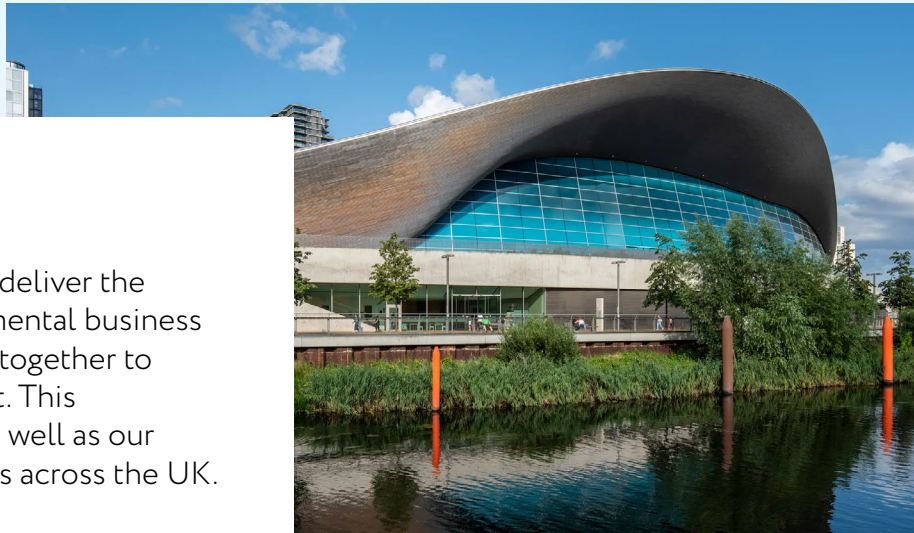
OUR VISION

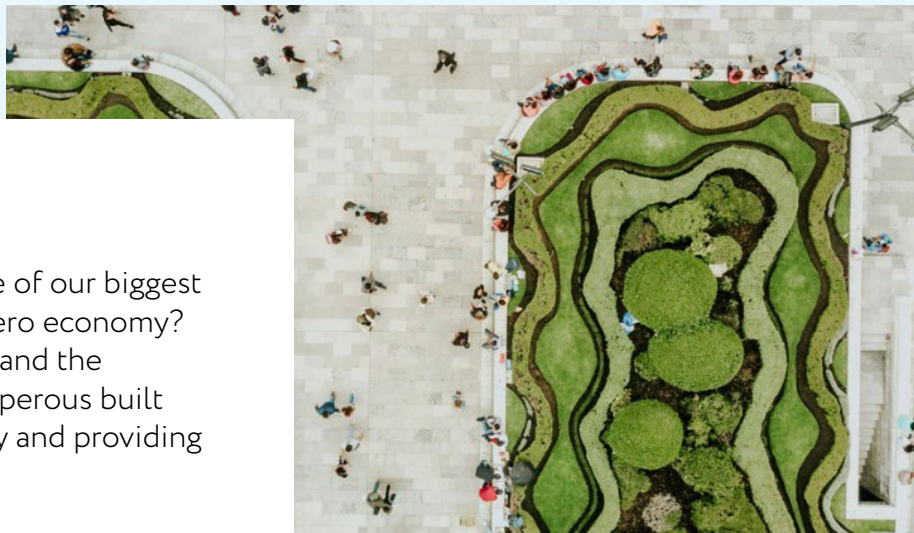
OUR MISSION
