- Clarify requirements of Extended producer responsibilities (EPR) based on research and emerging regulations being developed by Defra.
- Discuss and give Defra industry feedback on the feasibility of expansion of Emissions Trading Scheme (ETS) and its implications on the waste sector.
- Review impacts of regularising waste streams across local authorities to maximise waste management efficiency.

## Water taskforce

### In line with the requirements of the Environment Act, the taskforce's aims will be to: (subject to group agreement)

- Discuss and identify issues of concern regarding flood mitigation policies with specific reference to soft and hard infrastructure (including looking at investment and financing for flood mitigation).
- Review water catchment management in view of climate change events, and risk map catchments based on NPPF and growth plans for Levelling Up. To consider this with the backdrop of water company plans.
- Consider investment for sewage treatment management in high risk areas where discharges prominent in public access areas. This would also consider infrastructure requirements for mitigation.

- Investigate and come to a position regarding review of WM3 regulations and ensure Defra are aware of industry concerns.
